DESIGN GUIDELINES

This application is for only ONE pre-approved historic district sign. The sign proposed in this application shall be one of the designs shown in the attached "Pre-Approved Historic District Signs" document. The proposed sign shall be displayed as a Professional Sign (PS), Wall Sign (WS), or Marquee Sign (MS), as described in the City Sign Ordinance. If approved, the proposed sign shall be constructed, affixed, and maintained in accordance with all Lockhart City codes, Ordinances, and Historic District guidelines. The Lockhart Historical Preservation Commission has pre-approved this application, if it is completed and the sign meets the following provisions:

- ✓ The sign shall be (check only one): Professional Sign (PS) ___ Wall Sign (WS) ___ Marquee Sign (MS) ___
- ✓ Sign shall be one of the "Pre-Approved Historic District Signs". Circle type: A B C D E F G
- ✓ Sign shall comply with Chapter 46 "Signs".
- ✓ Sign shall have 1__ or 2__ faces with permanent painted lettering (check one).
- ✓ Sign shall be hung safely at a minimum clearance height of 7 feet, if above a walkway.
- ✓ Sign shall NOT be displayed so as to cover, damage, or distract from the historic design elements of the building.
- ✓ Sign shall not be painted on an unpainted masonry wall.
- ✓ Sign shall not exceed the overall maximum dimensions given for the pre-approved design. It may be SMALLER.
- ✓ Sign shall be made of a wood material (minimum thickness of ½ inch) with all sides and edges finished.
- ✓ Sign shall have a contrasting painted and/or raised border around its full perimeter (min. ¾ inch width).
- ✓ In the space below, please provide a detailed description of the sign design, size, and where and how displayed (attach additional sheets, if needed): _____

CERTIFICATE FOR ALTERATION- SCOPE OF WORK QUESTIONNAIRE

Additional information may be needed to complete the application and review process. Final review and action on the application for the Certificate for Alteration by the Lockhart Historical Preservation Commission in a public meeting may be required. Any required explanations to answers given shall be attached. The proposed improvements represented on this application will be the limit of construction and alteration work undertaken.

Construction shall not begin prior to authorization by the approval of the Certificate for Alteration.

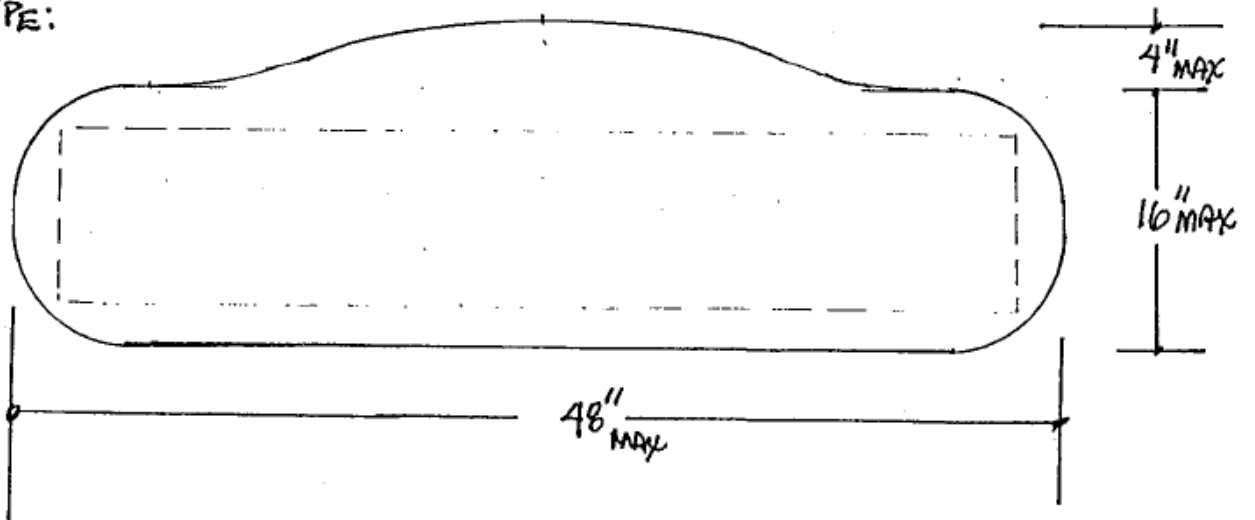

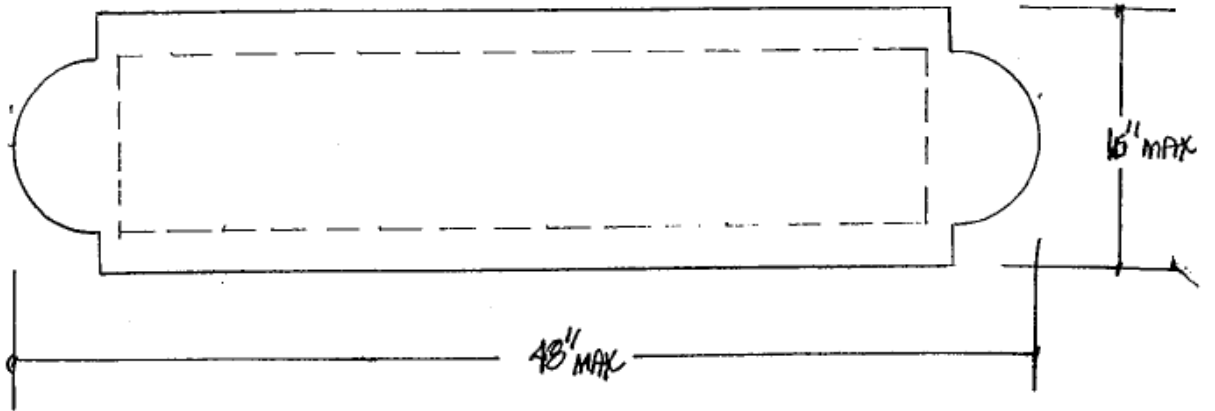

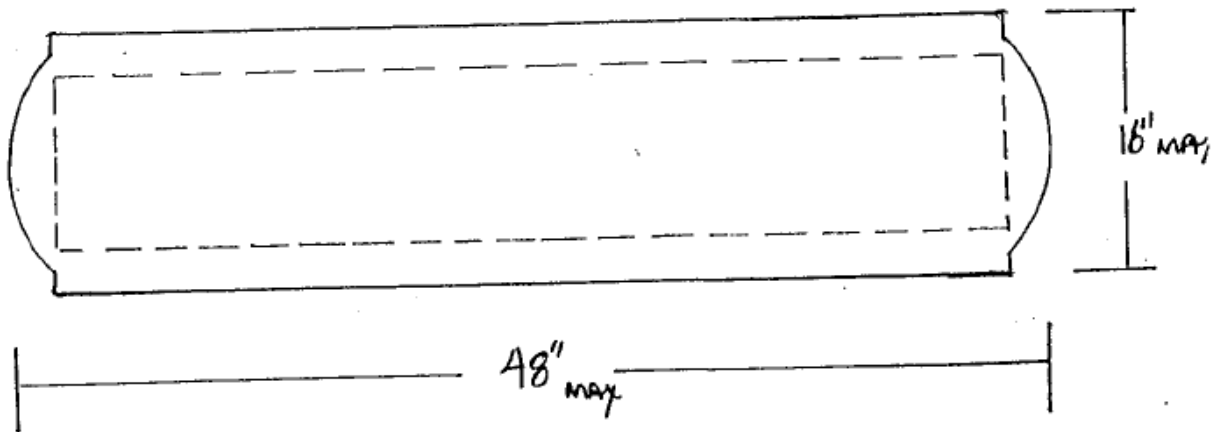
