Mayor White opened the work session and advised the Council, staff and the audience that staff would provide information and explanations about the following items:

Mayor White announced that Mayor Pro-Tem Sanchez would not be at the meeting.

## **DISCUSSION ONLY**

A. DISCUSS MINUTES OF THE CITY COUNCIL MEETING OF OCTOBER 20, 2015. Mayor White requested corrections to the minutes. There were none.

## **B. DISCUSS RESOLUTION 2015-12 APPROVING THE PROPERTY TAX APPRAISAL ROLL,** WITH TAX AMOUNT, PRESENTED BY THE CALDWELL COUNTY APPRAISAL DISTRICT FOR THE 2015 TAX YEAR, PURSUANT TO TEXAS TAX CODE, SECTION 26.09.

Mr. Hinson stated that Section 26.09 of the Property Tax Code requires approval by the City Council of the City of Lockhart's appraisal roll with tax amounts entered by the assessor. He reviewed the appraisal roll as attached to the Resolution. Mr. Hinson recommended approval.

## C. DISCUSS RESOLUTION 2015-13 CASTING VOTES FOR THE CALDWELL COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS FOR THE TERM OF OFFICE FROM JANUARY 1, 2016 UNTIL DECEMBER 31, 2017.

Mr. Rodgers stated that the Council voted during the September 15, 2015 Council meeting to approve Resolution 2015-10 that provided the City's nomination (Miguel Islas) as a name to be placed on a ballot for the CCAD Board of Directors, which was submitted to the CCAD for inclusion on a ballot. Attached is the ballot that the City received from the Caldwell County Appraisal District (CCAD) requesting that each taxing entity cast votes on the ballot for the CCAD Board of Directors for the term of office from January 1, 2016 to December 31, 2017. The City of Lockhart is entitled to cast 425 votes. Deadline to submit the votes to the CCAD is December 15, 2015. Staff will submit the necessary documentation to the CCAD after the Council has cast their vote(s).
