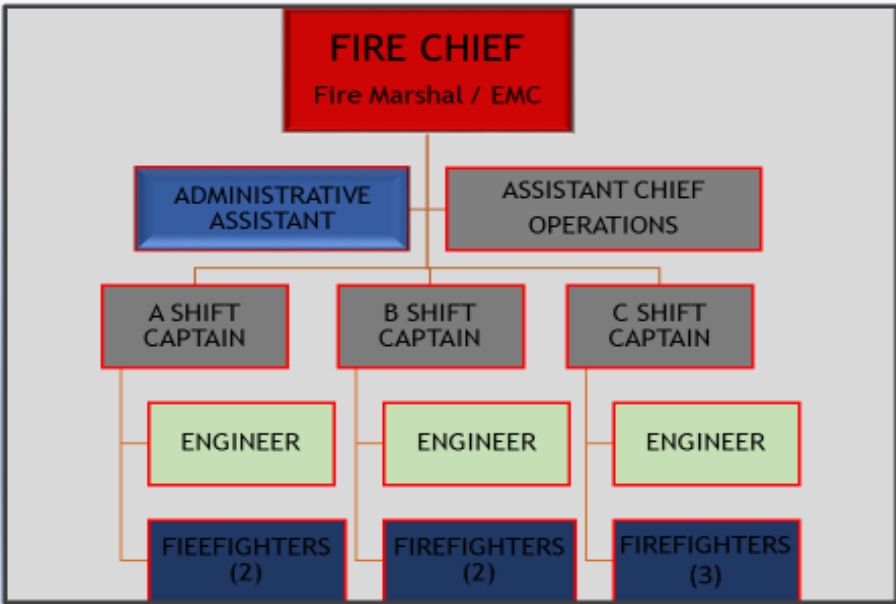
### CORE VALUES

### LOCKHART FIRE RESCUE ORGANIZATION CHART

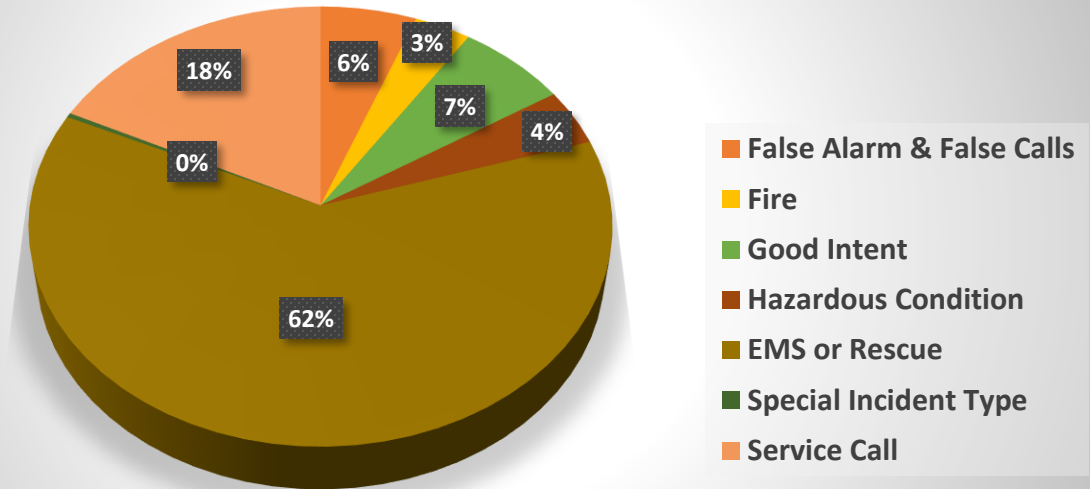

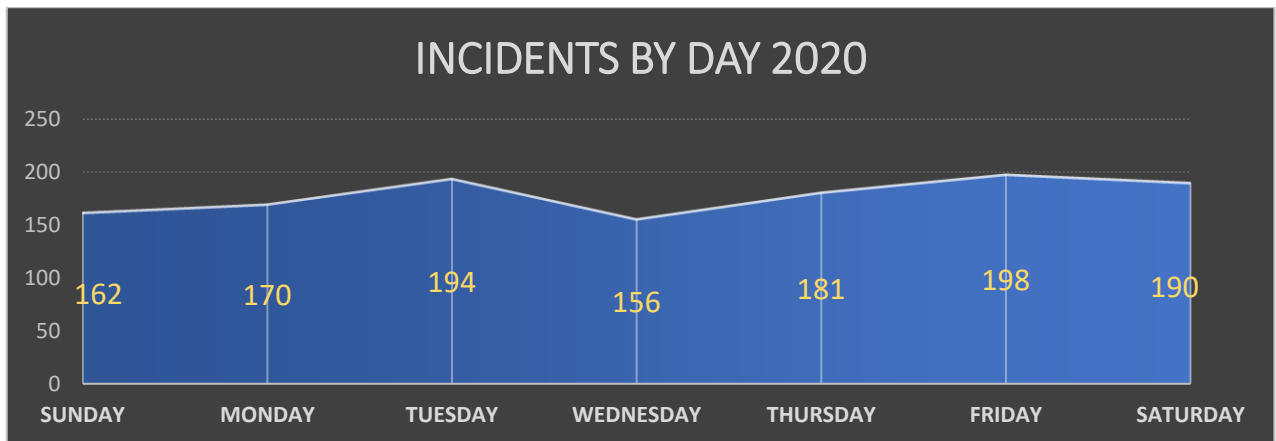

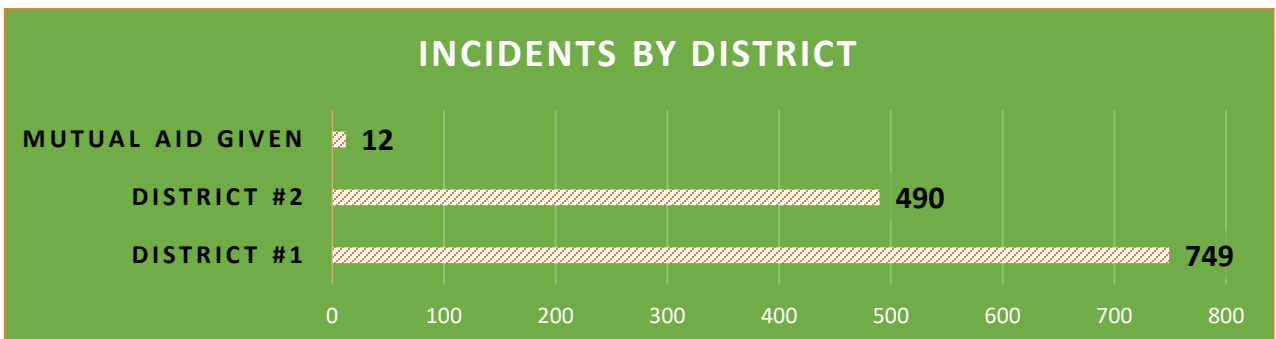
### INCIDENT TYPE SUMMARY 2020

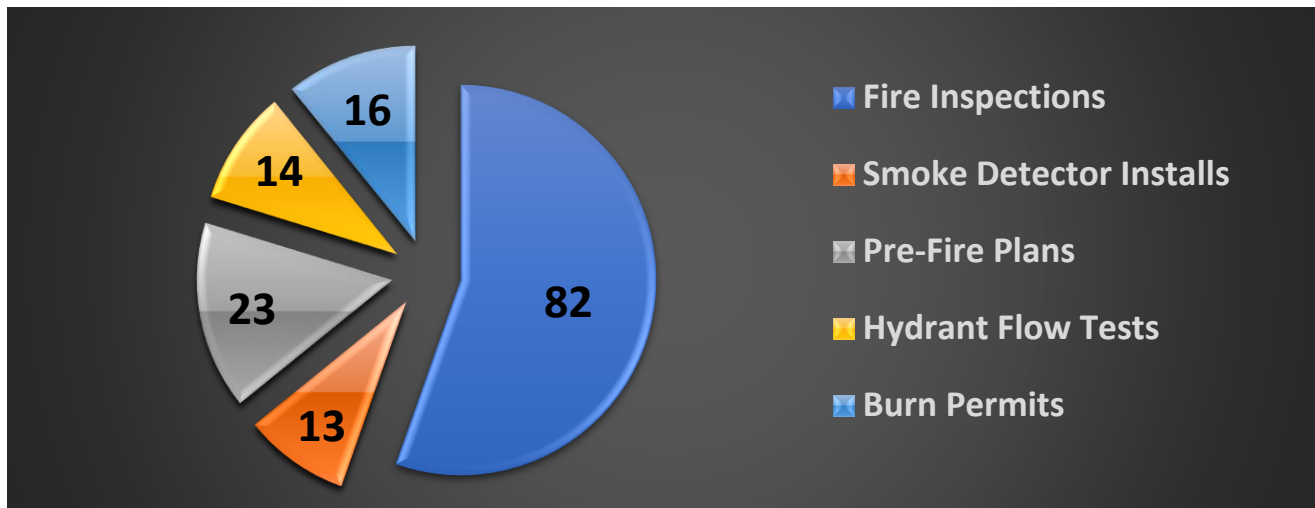

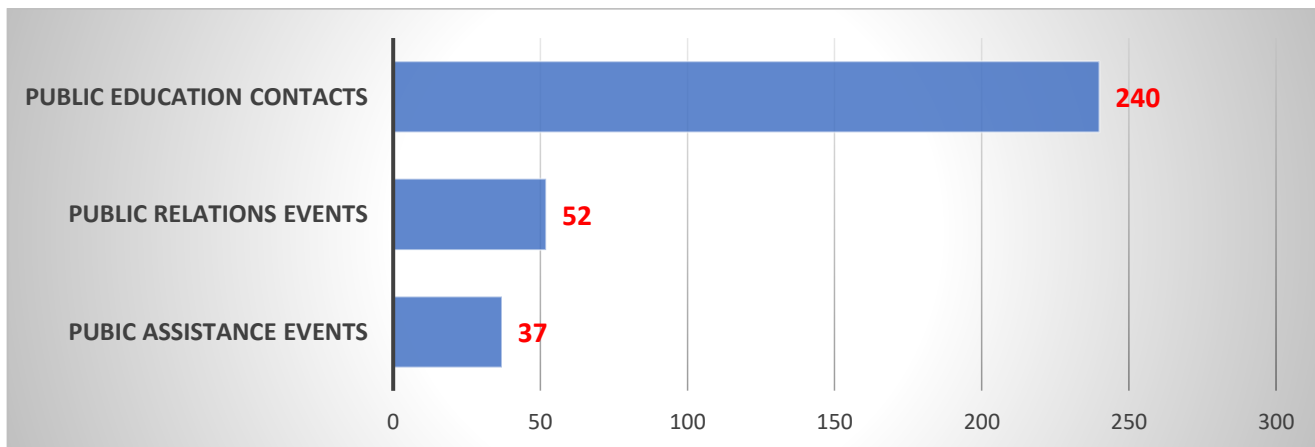
### COMMUNITY RISK REDUCTION

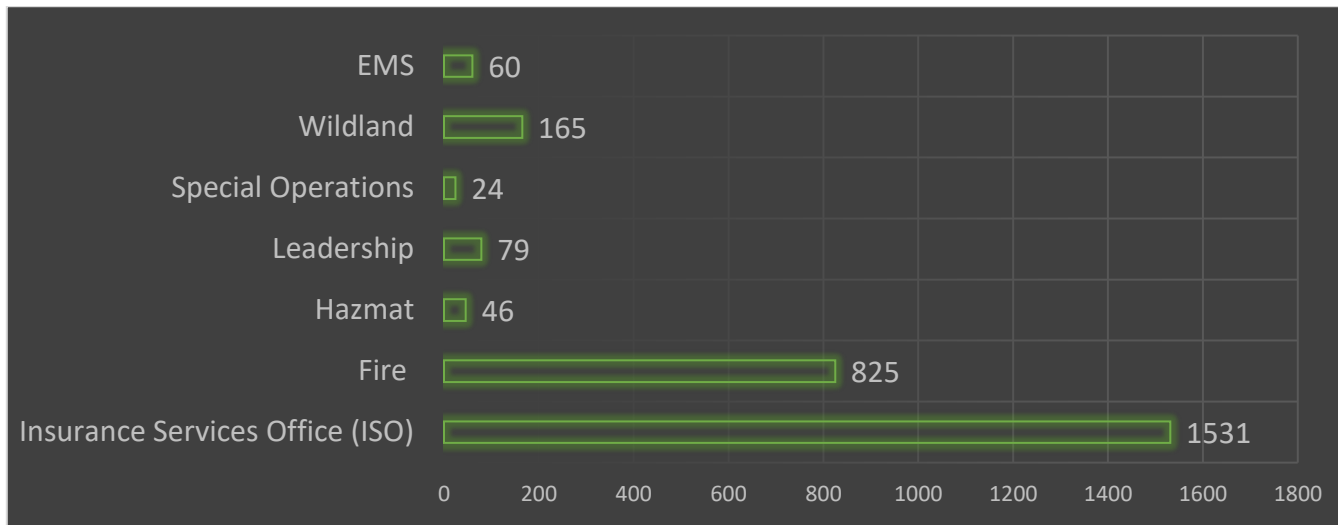


# Lockhart Fire Rescue

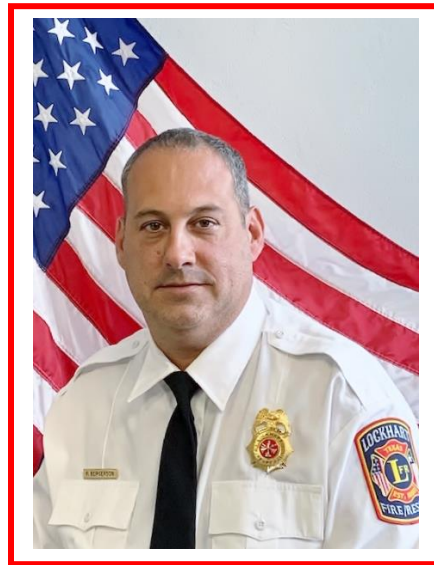

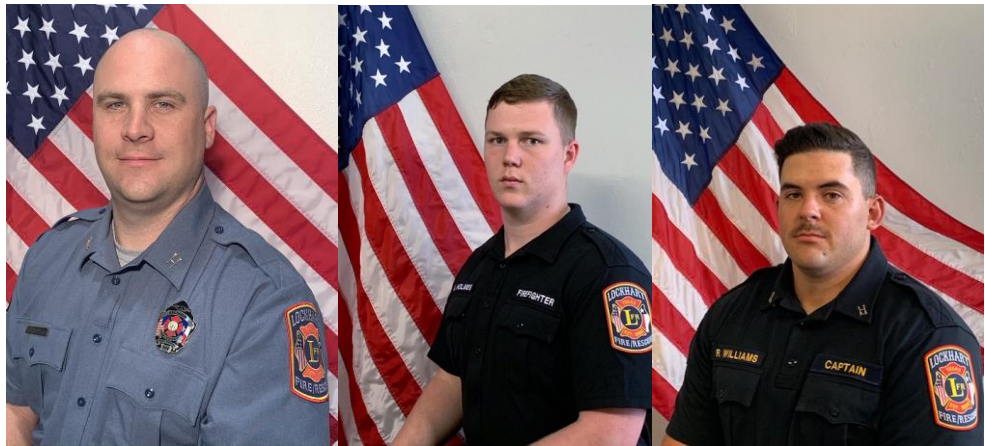

- **August** – Completed annual PPE Inspections as required by the Texas Commission on Fire Protection (TCFP).



- **October 30, 2020** – Lockhart Fire Rescue participated in Halloween at Fire Station #1.



- **November 19, 2020** – Leadership Lockhart sponsored by Lockhart Chamber of Commerce toured Fire Station #2 at 1911 Borchert Dr. and participated in firefighter skills. Two Life Pak 1000 Automatic External Defibrillators (AED) were purchased with CARES Funds and put into service.

### 2020 HIGHLIGHTS

- The largest event of 2020 was the emergence of the coronavirus. COVID-19 as it is referred to is caused by the severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), a new virus in humans causing respiratory illness which can be spread from person-to-person. COVID-19 caused widespread disease in the United States with over 300,000 deaths in the year 2020. The economy suffered also with widespread shutdown of schools, businesses, and large events. The State of Texas was under a mandatory mask order from July 2, 2020 thru December 2020. A massive effort led by the government to test and quarantine individuals affected by COVID-19 was in place until a vaccine was developed in December 2020.



- **December 29, 2020** – Firefighter Jamesy True-McInerney, Captain Zach Boydston, and Assistant Chief Ryan Bergerson were the first Lockhart Firefighters to receive the COVID-19 vaccine from HEB.
