Chairman Neal called the meeting of the Civil Service Commission to order on this date at 6:30 p.m.

Agenda

1. Discussion and/or action regarding approval Commission minutes of May 18, 2020.

Chairman Neal requested corrections to the Civil Service Commission minutes of May 18, 2020. Commissioner Sanders stated there was a type-o on Item 2. The word edibility should be eligibility.

Commissioner Sanders made a motion to approve Civil Service Minutes of May 18, 2020 as corrected. Commissioner Strey seconded. The motion carried by a vote of 3-0).

2. Discussion and/or action regarding approval of Exam Source List for the position of Fire Engineer (Lockhart Fire Department) replacing the Exam Source list previously approved on July 17, 2017.

Ms. Bowermon stated that the current exam source list for Fire Engineer was approved in 2017. At that time in 2017, the list from 2015 was being amended to include the most recent edition of the IFSTA: Pumping Apparatus Driver/Operator Handbook while all other sources remained the same. Now in 2020, Fire Chief Jenkins has reviewed the list and recommends a new list be approved, keeping the IFSTA source but replacing the remaining 3 with: Evidence-Based Practices for Strategic and Tactical Firefighting, Fully Involved Leadership: Successful Strategies in Leadership from the Firefighter to the Chief, and the Lockhart Fire Rescue Standard Operating Guidelines. Ms. Bowermon further stated that dated internal policy sources would be reconsidered each year to ensure the most recent departmental polices were being used in promotional exams and to clarify to employees which polices to study.

There was further discussion.

Commissioner Strey made a motion to approve the Exam Source List for the position of Fire Engineer (Lockhart Fire Department) replacing the Exam Source list previously approved on July 17, 2017. Chairman Neal seconded. The motion carried by a vote of 3-0.

3. Discussion and/or action regarding approval of Exam Source List for the position of Fire Captain (Lockhart Fire Department) replacing the Exam Source List previously approved on July 20, 2015.

Ms. Bowermon stated the current Fire Captain exam source list was approved in 2015. The 2015 list contains 2 books and a collection of articles. The articles are not easily obtainable to study and there is a 6th edition of the IFSTA: Fire and Emergency Services Company Officer, the current list uses the 5th edition. Fire Chief Jenkins has reviewed the list and proposes to replace it with 4 sources: IFSTA: Fire and Emergency Services Company Officer, 6th edition, IFSTA: Structural Fire Fighting: Initial Response Strategy and Tactics, 2nd edition, The New Company Officer, and No Nonsense Leadership: A Realistic Approach for the Company Officer.

There was further discussion.

Commissioner Sanders made a motion to approve the Exam Source List for the position of Fire Captain (Lockhart Fire Department) replacing the Exam Source List previously approved on July 20, 2015. Commissioner Strey seconded. The motion carried by a vote of 3-0.

4. Discussion and/or action regarding amending Section 143.023(4) of the Lockhart Fire Fighters' and Police Officers' Civil Service Commission Rules and Regulations regarding waiting periods after rejection.

Ms. Bowermon stated the Local Rule (LR) 143.023 addresses reasons applicants are rejected for entry level fire fighter and police officer positions and waiting periods to reapply after rejection. In LR 143.023 if an applicant fails the entry written examination or the entry physical agility testing, the applicant must wait one full year before becoming eligible to reapply. However, both the Fire and Police Departments have experienced applicants that almost pass, for example score a 68 of fail one task in the physical agility testing. These applicants could potentially be qualified certified applicants capable of passing the entry exams at a later date. Often applicants that struggle with the physical agility test will spend a few months condition and then be fit to pass the exam. After discussing the waiting period with both the Police Chief and Fire Chief, it is being recommended to amend the local rules and remove the one year waiting period when an applicant fails the entrance examinations. This will allow the departments more opportunity to evaluate applicants.

There was further discussion regarding the clarity of the language proposed for the amendment.

Commissioner Sanders made a motion to approve amending Section 143.023(4) of the Lockhart Fire Fighters' and Police Officers' Civil Service Commission Rules and Regulations regarding waiting periods after rejection and using the language:

(a) Applicant fails to pass any part of the entrance examinations. Applicant who fails any part of the entrance examinations is eligible to reapply for any subsequent entrance examinations;

AND last paragraph as,

Any applicant rejected must wait one year before re-applying for employment, unless a shorter or longer waiting period is indicated by the reason for the rejection, such as an unacceptable driving record.

Commissioner Strey seconded. The motion carried by a vote of 3-0.

5. Discussion and/or action regarding amending Section 143.034 of the City of Lockhart Fire Fighters' and Police Officers' Civil Service Commission Rules and Regulations regarding providing candidates copies of questions when an appeal is filed.

Ms. Bowermon stated Local Rule Section 143.034 requires the Civil Service Director to give the promotional candidate a copy of an appealed question along with the correct answer and page number from which the question was written. Civil Service Attorney Julia Gannaway reviewed Local Rule 143.034 and recommended, in order to avoid possible conflict between the state statue and the Local Rules, the Commission consider removing this requirement of releasing copies of questions prior to the Commission being notified of the appeal.

There was further discussion.

Chairman Neal made a motion to approve amending Section 143.034 of the City of Lockhart Fire Fighters' and Police Officers' Civil Service Commission Rules and Regulations regarding providing candidates copies of questions when an appeal is filed. Commissioner Strey seconded. The motion carried by a vote of 3-0.

- 6. Director's Report.
 - Police Sergeant exam was held August 13, 2020, anticipate the 2 sergeant vacancies to be filled in the upcoming weeks;
 - Police entrance exam was held August 22, 2020;
 - Fire Fighter entrance exam to be scheduled in early fall, exploring larger locations to hold written portion to ensure adequate spacing.
- 7. Adjournment.

Commissioner Sanders made a motion to adjourn the meeting. Chairman Neal seconded. The motion carried by a vote of 3-0. The meeting was adjourned at 7:43pm.

SUMMARY OF ITEM

A Captain vacancy exists and it is necessary to hold a Fire Captain promotional exam.

Chapter 143.030(b) requires that the exam be first opened to Engineers with 2 years of experience. Chapter 143.028(a) requires that a firefighter must have served 4 years in the fire department to be eligible for a promotion to Captain.

 By opening the exam to Engineers with 2 years in that position and 4 years of service in the department, no employees would be eligible for the exam.

Chapter 143.030(d) requires that if there is not an adequate number of Engineers with 2 years of experience, the Commission may open the exam down to Engineers with less than 2 years of experience (in other words, all Engineers).

 By opening the exam to all Engineers with 4 years of service in the department, only employee would be eligible.

To prevent a delay in filling the Captain vacancy, staff requests that the Commission open the Captain exam to all Engineers, regardless of tenure AND waive the 4 years of service in the department requirement, which would make 3 employees eligible.

Our Commission Local Rules require that 3 employees sit for a promotional exam. To prevent delay in filling the promotional vacancy, staff also requests that the Commission waive the rule of "3" and allow that only 2 employees must sit to take the Captain exam – for this exam only.

STAFF RECOMMENDATIONS

Staff recommends approval of opening the current Fire Captain Exam (date to be determined) to all Fire Engineers within the Lockhart Fire Department, regardless of tenure; waiving the 4 years of service in the department requirement; and provide that two candidates ensure a competitive examination, thereby suspending/waiving the requirement of three candidates for this examination only.

CHAPTER 143.028 TK LAC

Sec. 143.028. ELIGIBILITY FOR PROMOTION. (a) Except as provided by Sections 143.013 and 143.102, a fire fighter is not eligible for promotion unless the person has served in that fire department in the next lower position or other positions specified by the commission for at least two years at any time before the date the promotional examination is held. A fire fighter is not eligible for promotion to the rank of captain or its equivalent unless the person has at least four years' actual service in that fire department.

- (b) Except as provided by Sections 143.013 and 143.102, a police officer is not eligible for promotion unless the person has served in that police department in the next lower position or other positions specified by the commission for at least two years immediately before the date the promotional examination is held. A police officer is not eligible for promotion to the rank of captain or its equivalent unless the person has at least four years' actual service in that police department.
- (c) If a person is recalled on active military duty for not more than 60 months, the two-year service requirements prescribed by Subsections (a) and (b) do not apply and the person is entitled to have time spent on active military duty considered as duty in the respective fire or police department.

CHAPTER 143.030 TXLAC

Sec. 143.030. ELIGIBILITY FOR FIRE DEPARTMENT PROMOTIONAL EXAMINATION. (a) This section does not apply to a municipality with a population of 1.5 million or more.

- (b) Each promotional examination is open to each fire fighter who at any time has continuously held for at least two years a position in the classification that is immediately below, in salary, the classification for which the examination is to be held.
 - (c) If the department has adopted a classification plan that classifies positions on the basis of similarity in duties and responsibilities, each promotional examination is open to each fire fighter who has continuously held for at least two years a position at the next lower pay grade, if it exists, in the classification for which the examination is to be held.



- (d) If there are not enough fire fighters in the next lower position with two years' service in that position to provide an adequate number of persons to take the examination, the commission may open the examination to persons in that position with less than two years' service. If there is still an insufficient number, the commission may open the examination to persons with at least two years' experience in the second lower position, in salary, to the position for which the examination is to be held.
- (e) If a fire fighter had previously terminated the fire fighter's employment with the department and is subsequently reemployed by the same department, the fire fighter must again meet the two-year service requirement for eligibility to take a promotional examination. In determining if a fire fighter has met the two-year service requirement, a fire department may not consider service in another fire department.
- (f) This section does not prohibit lateral crossover between classes.
