Information for Communities and Survivors Recovering from Hurricane Harvey

SBA Opens Additional Disaster Loan Outreach Centers (DLOCs)

Survivors can still meet face to face with experts who can answer their questions about U.S. Small Business Administration (SBA) disaster loan programs.

A DLOC opened **Dec. 11, 2017**, at the Jasper County Annex in the city of Jasper. Center hours are Monday to Saturday from 9 a.m. to 6 p.m., until further notice.

Another DLOC will open on **Friday, Dec. 15** at the American Legion Hall in the city of Anahuac. Hours will be Monday to Friday from 9 a.m. to 6 p.m., and Sunday from noon to 5 p.m.

Determination Letters and Appeals

Survivors must read their determination letters from FEMA carefully to understand the reasons for the decision, and have the right to appeal.

If they decide to appeal, survivors need to do so within 60 days from the date of their <u>determination</u> letter. Applicants can submit additional documentation supporting their appeal by mail or by dropping it off at a Disaster Recovery Center.


FEMA mitigation specialists will be at hardware and home improvement stores through Dec. 16, 2017.

What is "Substantial Damage"?

As survivors in Texas rebuild after Hurricane Harvey, some homeowners will face the issue of "substantial damage" to their residences.

That decision is made at a local government level, generally by a building official or floodplain manager. In general:

- FEMA does <u>not</u> make a determination of substantial damage and does not notify any owner of a damage determination.
- This information is important for property owners deciding whether to –or how to– repair or replace a damaged dwelling, and if additional work such as elevating the structure is needed to comply with local codes and ordinances.

In-Person Help at Disaster Recovery Centers (DRCs)

Although DRCs start opening when registration begins, they continue helping survivors even after the registration period has ended.

Applicants who have questions about disaster assistance can visit any Disaster Recovery Center (DRC) in Texas.

Disaster Distress Helpline The holidays can be difficult, especially after a disaster. If you need to talk to someone, call **800-985-5990** or **800-846-8517** (TTY), or text **TalkWithUs** or **Hablanos** (Spanish) to **66746** to connect with a trained counselor. It's free, confidential and open 24/7.

Transitional Sheltering Assistance (TSA) Program Extension

Survivors staying in hotels under the TSA program may be eligible to stay longer.

For information on continued TSA eligibility, guests can:

- Call the FEMA Helpline at **800-621-3362** (voice, 711 or VRS) or **800-462-7585** (TTY).
- Log into their account on DisasterAssistance.gov/.
- Visit a Disaster Recover Center (DRC). For DRC locations and hours go to <u>www.fema.gov/DRC.</u>
- Ask the front desk to check the CLC Lodging web portal to see if they are eligible to stay longer.

If you need legal assistance due to Harvey, call the Young Lawyers Division of The American Bar Association at 800-504-7030. Survivors can receive free counseling on insurance claims, landlord- tenant issues, home repair contracts, foreclosures, replacement of legal documents destroyed or damaged by the storm and other legal matters.
