## City-wide clean-up on Saturday, July 18

The City of Lockhart has rescheduled its city-wide residential cleanup for current residential utility customers on Saturday, July 18.

The clean-up, which is sponsored by the city and Central Texas Refuse, was originally scheduled for April but was postponed due to unknown health safety concerns at the time.

Bulky item pickup charges will not be applicable on certain eligible items.

All loose materials must be in bags or in containers that cannot weigh more than 60 pounds.

All materials must be out at the property line by 8 a.m. July 18. Please do not put your materials out prior to July 11.

Do not put material in the street, where it could reduce visibility at intersections

## **Eligible items**

- Appliances such as washers, dryers and stoves
- Carpeting measuring less than 4 feet long
- Furniture
- Scrap metal measuring less than 4 feet long
- Treated wood
- Mattresses

## Not allowed

- Freon appliances such as refrigerators, freezers and air conditioning units
- Televisions and computers
- Automotive products/fluids
- Pain
- Hazardous materials
- Demolition/construction debris and metal fencing
- Tires
- Batteries, ammunition or explosives
- Concrete or rocks
- Railroad tie lumber
- Pianos, hot tubs, motorcycles or items larger than a typical appliance

# Loan program brings relief to business owners

The COVID-19 Recovery Loan program was created in April, making zero interest loans of up to \$5,000 or \$7,500 available to non-essential businesses.

All loans have a 36-month repayment schedule and will not be charged interest if paid in full by the maturity date. A promissory note must be executed. No payments are required prior to October 1, 2020.

The application period for the loan will remain open until September 30, 2020, until funding has been exhausted, or until the city determines the program goals have been satisfied.

## Keep grass short to avoid costly penalties, pests

City ordinances prohibit property owners and occupants from allowing stagnant water to accumulate on their properties and require grass and weed heights not to exceed 12 inches in yards and vacant lots.

High grass and weeds pose hazards that include increased risk of fires and creating a habitat for pests like rodents, snakes, mosquitoes and chiggers.

If your grass is taller than 12 inches, a code violation notice will be sent regular mail and a placard will be placed on the lot. The owner or occupant will have 10 days to comply.

Consequences for failure to comply can range from the city mowing the lawn and billing the resident to a complaint being filed in municipal

In most cases, if the owner does not comply within the 10-day period, the city will send a contractor to mow the property and send the owner the bill. The average charge to mow a residential lot is approximately \$190. The owner has 30 days to pay the bill to avoid a lien being placed on the property.

If a complaint is filed in municipal court and the owner or occupant is found guilty, the fine ranges from \$500-\$2,000 and can be assessed for each day the property is in violation of the ordinance.

These tips can help you prevent mosquitoes:

- Repair window and door screens
- Mow grass and tall weeds
- Cut back shrubs and vines
- Treat shaded areas with a professional pest control application or do-it-yourself spray treatment
- Remove tires and junk
- Eliminate any place water can collect and be retained for 7-10 days, especially where piles of soil or leaves are present.

### Ways to pay your utility bill
