- ADDITIONAL PAVEMENT REQUIRED AT INTERSECTIONS TO ACCOMMODATE STREETSCAPE DESIGN AND PEDESTRIAN SAFETY
- MORE DETAILED BREAKDOWN OF COSTS FOR LIGHTING, PLANTING, AND IRRIGATION





PROPOSED MASTER PLAN






















SAN ANTONIO STREET SECTION ORIENTATION LOOKING WEST BETWEEN MAIN AND COMMERCE






















SOUTH MAIN STREET SECTION ORIENTATION LOOKING NORTH BETWEEN MARKET AND PRAIRIE LEA














NORTH MAIN STREET SECTION ORIENTATION
